1. A valid passport
2. Completed and signed form **DS-156** for all applicants and form **DS-157** if applicable.
3. A 5X5 cm **photograph**
4. Proof of payment of **the Shekel equivalent of the \$131 USD dollar** payable at a participating branch of the **Israeli Post Office**.

You should bring any other required and suggested documents as indicated in the section for your specific visa type on the VisaPoint website. Please note: If you fail to bring the required documents, you will not be interviewed. You will be asked to return at a later date and your travel plans may be severely affected.

**By scheduling an appointment you are asserting that you will come completely prepared. In addition to all the other documents, if you used the VisaPoint Web Service you must click on the *Generate DS-156* link on the My Info Page or if you used the VisaPoint Live Agent Service you must go to <http://evisaforms.state.gov/>, complete and print the DS-156 form for each applicant who will be applying, and present it the day of your appointment. If you appear for your interview without the required documents, processing cannot be completed and further processing may be significantly delayed.**

Please do not bring backpacks, bags, luggage, strollers or electronic equipment to the interview. If your visa is approved, after your interview the consular officer will retain your passport in order to finish processing your visa. You will be given a "Passport Delivery Request" form, which is to be paid at participating **Israeli Post Office** branches. Payments may be made at the branch located near the Consular Section or by calling the post office customer service center at 171. Upon completion of the visa process, the passport with visa

will be delivered to the address provided by the applicant. The applicant may verify the status of the delivery by using the delivery number listed on the "Passport Delivery Request" form, at the following website: <http://www.israelpost.co.il/>. Neither the Consular Section nor the Visa Information Service have any information regarding the delivery status of passports.
